On behalf of the H&R Block Political Action Committee, enclosed for filing is FEC Form 3X, Report of Receipts and Disbursements, for the period July 1, 1999 through December 31, 1999.

An internal audit of the books, records and previously filed FEC Reports of BLOCKPAC indicated a need to amend FEC Forms 3X for (1) the period April 1, 1998 through June 30, 1998; (2) the period July 1, 1998 through September 30, 1998; (3) the period October 1, 1998 through November 23, 1998; (4) the period November 24, 1998 through December 31, 1998; and (5) the period January 1, 1999 through June 30, 1999. The nature of the amendments for each such Report was as follows:

April 1 1998 through June 30, 1998 Report: Corrected the identification of one itemized contributor in Schedule A; corrected \$27.85 overstatement of unitemized contributions (Line 11(a)(ii)) that resulted from a mathematical error in calculating the total.

July 1, 1998 through September 30, 1998 Report: Brought forward corrected Cash on Hand at Beginning of the Reporting Period (Line 6(b)); Corrected the amount of the receipts during the period for two itemized contributors in Schedule A (one \$0.01 overstatement, one \$80.00 understatement); Corrected the year-to-date total for one itemized contributor; Corrected \$178.27 overstatement of unitemized contributions (Line 11(a)(ii)) that resulted from the inclusion of itemized contributions as unitemized contributions (as noted above) and a mathematical error in calculating the total.

October 1, 1998 through November 23, 1998: Brought forward corrected Cash on Hand at Beginning of the Reporting Period (Line 6(b)); Corrected the amount of Itemized and unitemized receipts in the period (Lines 11(a)(i) and (ii)) due to incorrect inclusion of November 30 payroll withholdings; Changed report of \$80.00 in unitemized individual contribution to a report of


January 1, 1999 through June 30, 1999: Brought forward corrected Cash on Hand at Beginning of Reporting Period (Line 6(b)); Corrected unitemized individual contributions (Line 11(a)(ii)) to eliminate \$660.81 in erroneously included contributions from the payroll period ended December 31, 1998 (such amount having previously been reported in the Report for the period ended December 31, 1998); Reported the year-to-date total of itemized contributions for one individual in Schedule A (which total had been omitted from the original Report).
