DURING THE MONTH OF JUNE, THE COMMITTEE HAS CONDUCTED VERY LITTLE FEDERAL CAMPAIGN ACTIVITIES. MOST STAFF ACTIVITIES WERE FOCUSED ON STATE ISSUES. ACCORDINGLY NO WAGES HAVE BEEN PAID FROM THE FEDERAL ACCOUNT FOR THE PERIOD. THIS AMENDED REPORT IS BEING SUBMITTED IN RESPONSE TO THE FEDERAL ELECTION COMMISSION LETTER DATED SEPTEMBER 7, 2007. THE REASON THE SCHEDULE H4 ALLOCATION RATIO IS INCONSISTENT WITH THE COMMITTEE'S CURRENT SCHEDULE H1 IS THAT THE ONLY TWO TRANSACTIONS LISTED ON THE H4 WERE VOID CHECKS FROM A PRIOR YEAR. THUS THE ALLOCATION RATIO IS DIFFERENT FROM THE CURRENT YEAR RATIO. THERE HAS BEEN NO REIMBURSEMENT FROM THE COMMITTEE'S NON-FEDERAL ACCOUNTS. THE COMMITTEE REGRETS ANY PROBLEMS THAT HAVE CAUSED . THE SECOND AMENDED REPORT IS BEING FILED AS A RESULT OF THE 4-20-07 AMENDED REPORT. THE ONLY ITEMS CHANGED ARE THE TOTALS ON LINES 11(a)(i) & 11(a)(ii).
