This letter is in response to your notice dated August 15, 2013 in which you identify the following three items from the Committee's 2012 year-end report which need to be addressed:

- 1. Amounts reported on Schedule A which appears to be from corporations
- 2. Amounts reported on Schedule A which appears to exceed the \$5,000 per calendar year contribution limit for individuals
- 3. Missing identifying information for individuals who contributed in excess of \$200 in the calendar year

In response to the first two items noted above, the Committee registered as a Nonconnected PAC on September 12, 2012 and

mistakenly failed to include a statement with its Form 1 indicating the Committee intended to be treated as an Independent Expenditure-Only Political Committee consistent with the U.S. Court of Appeals for the District of Columbia Circuit decision in SpeechNow v. FEC, and that it intends to raise unlimited funds. The Committee has not, and will not, use the funds it raises to make contributions, whether direct, in-kind, or via coordinated communications, to federal candidates and committees. We, therefore, respectfully request you adjust your records accordingly to indicate the Committee is an Independent Expenditure-Only Political Committee.

In response to the third item noted above, the Committee makes best efforts to obtain identifying information for all contributors by:

- 1. Including a clear and conspicuous request for contributor information and informing contributors of the requirements of federal law for the reporting of such information in the Committee's original solicitation requests
- 2. Following-up with either a written or a documented oral request for missing information within 30 days of receipt of the contribution
- 3. Filing amendments to the originally filed reports to include missing contributor information when subsequently received Federal Election Commission September 9, 2013 Page 2
