As you are aware DAF is a completely volunteer organization. I have tried to answer your questions as quickly as possible and keep up to date with the filing requirements.

Enclosed are amended filings for the July 15, 1996 Quarterly, the October 15, 1996 Quarterly and the 12 Day Pre-General Reports. All have been corrected to show the proper reporting dates. I used the European date system on the July Quarterly and repeated it thereafter. As to the July Quarterly and the Pre-General these are the only changes.

The October 15 Quarterly has been corrected as to the missing data. On lines 11(a)(iii) and 11(d) and 19 I have put 0s as in the original they were blanks. On lines 22 and 30 I have provided the numbers which were included in the total shown on the original; in doing the report I calculated the correct total but omitted showing the data. 
