Please note that the enclosed Schedule D of TeacherPAC's 2016 third quarter filing reflects debts (administrative expenses advanced by myself) that are being forgiven. Those expenses have been reduced to a zero balance on Schedule D, as instructed by FEC analyst Maureen Benitz on October 3, 2016.

Because the debt forgiveness is considered a contribution, the total amount of debt forgiveness is reported as an individual itemized contribution, 11 (a) and on Schedule A, and offset on line 21 (b) of the Detailed Summary Page as a federal operating expenditure, since the contribution amount is not an actual dollar amount received as a cash contribution.
