-Your calculations for Lines 7, Column B and 8, Columns A and B appear to be incorrect. FEC calculations disclose these amounts to be \$37,282.50 and \$18,902.50, respectively. Please provide the corrected totals on the Summary Page.

-The totals listed on Lines 30 and 31, Column B of the Detailed Summary Page appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
