Dear Ms. Kitchen:


This letter is a follow-up to our conversation concerning your letters of August 23, 2000 and September 14, 2000. Please note that we did not become aware of these letters addressed to David Feinman until you called me a few days ago.

Next Generation appreciates your bringing to its attention the delay in transmittal of certain conduit contributions. It has implemented new procedures to prevent this from recurring. In fact, since the first quarter of this year, the period covered by your letter, Next Generation has not conducted contributions so there have been no other delayed transmittals.

The new procedures for conducting contributions will involve Next Generation immediately sending along the contributions rather than batching them or waiting for personal contact with the candidate or the candidate's representation.

We appreciate your consideration in this matter.
