Federal Election Commission,

I am filing this amendment to resolve several issues with our first-quarter report.

First, I made an error on line 11(a)(ii) on the original report. I listed our unitemized contributions as \$280 instead of \$295. I can offer no explanation for this mistake but acknowledge that I am at fault.

Second, the transcribed version of the original report contained several errors. Line 18(b) listed \$2280 under Levin Funds; this number was our total contributions. (We do not use Levin Funds.) Lines 21(a)(i) and 21(a)(ii) both contained \$2280 although we only use one account. Lines 21(b) and 21(c) both read \$0 while Lines 22 and 23 both read \$45; these numbers were the reverse on the original. Strange numbers were input into several places in Line 30; I can offer no explanation as to where these numbers came from. Section III was completely incorrect. I cannot speculate as to how these errors occurred as the information in the attached PDF of the original paper report is completely correct (outside of the erroneous \$280 and corresponding calculations.)


