

**MISCELLANEOUS TEXT (FEC Form 99)**

In response to the Request For Additional Information dated February 10, 2015, we reviewed our records to determine why the ending report amount for the 2014 October Quarterly report was negative. **Amended:**

**2013 October Quarterly Report:**

Added a disbursement for \$6333.14 to Skyagunsta Inc for website development on 9/9/13.
