2. Your amended report discloses additional receipts of Levin funds totaling \$11,000 on Line(s) 1(a) of the Schedule L Aggregation Page that were not disclosed on your original report. Please provide clarifying information as to why this activity was not disclosed on your original report. (11 CFR §300.36)


