
Please find attached amendment of Russ for Wisconsin's 2016 Year End Report. While performing an end of campaign audit an error was discovered and is corrected in the attached report.

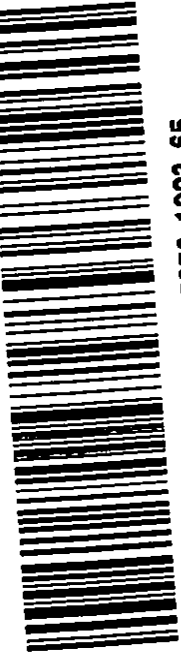

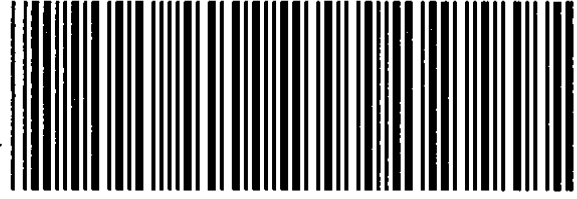

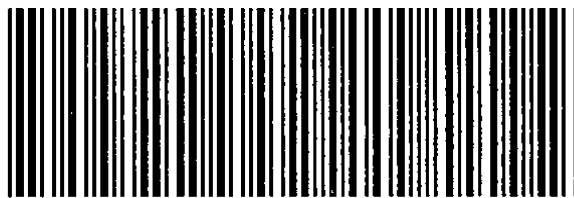
