We are in receipt of your letter dated August 20, 2008, concerning the re-designation of funds originally intended for the 2008 general election fund of Hillary Clinton for President.




Dear Shelly:

If we do not hear back from you by August 28, 2008, we will automatically refund your contribution. In order for us to redesignate your contribution, we must receive this letter or your approval via our website.


