Your most recent letter has requested clarifying information for two receipts reported on Schedule A supporting Line 15 of the Detailed Summary Page. The NRSC reported a vendor refund from "Chubb Group of Insurance Cos." during the month of April. It is not uncommon for an insurance company to pay a claim to an entity that it ensures. A detailed review of our reports will show that the NRSC pays Chubb for insurance coverage each year. The NRSC also received a refund from the Mandarin Oriental DC during the month of April. A detailed review of our reports will show that the NRSC paid the Mandarin Oriental in November and December of 2004. The NRSC has already disclosed payments to each of these entities and no further amendments are required.
