The undersigned serves as counsel to Citizens for Joe Miller ("the Committee"). We are in receipt of your Request for Additional Information ("RFAI") in which you have asked the Committee to specify on Line 5b of the Committee's Form 1 the name of the candidate, office sought (including state) and party affiliation.

In response, the Committee is amending its Form 1 to indicate that the candidate would be Joe Miller (if an office is sought in the future), the state is Alaska and the party affiliation is Republican. We have, at your direction, checked the box for "Senate" although no candidacy has been determined or triggered. You have advised that since the office of Senate is the last office sought by Joe Miller, that is the reason for checking the Senate box on Line 5b.

Attached you will find a copy of the letter filed by the Committee treasurer, Bernadette Kopyy, at the time of the filing of the Committee's Form 1, which states that the Committee has not raised or spent \$5,000 in furtherance of candidate status and, as such, has not triggered any requirement that a Statement of Candidacy be filed.



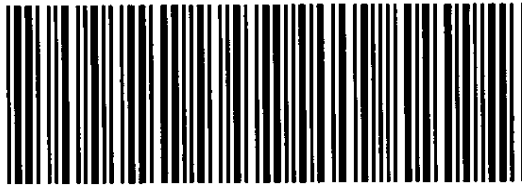
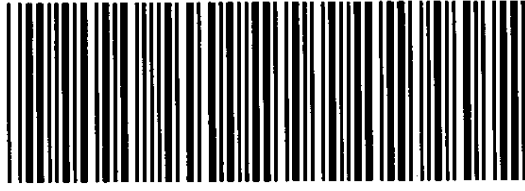
