Dear Ms. Chrzan:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The Summary Page discloses \$31,733.90 on Line 6(c), but the Detailed Summary Page shows the Line 19 total to be \$31,995.43. These figures should be the same. Please amend your report accordingly.

-It appears that the figures you have disclosed on Line 29 of the Detailed Summary Page has been inadvertently recorded on the incorrect line. Please amend your report to disclose your figures on the correct lines of the Detailed Summary Page.

-Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$18,081.28 in individual itemized contributions. The sum of the entries itemized on Schedule A, however, indicates the total to be \$15,813.89. It appears page 5 of Schedule A is missing. Please amend your report to clarify the discrepancy.

-Please provide the total(s) for Line 21(c), Columns A and B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
