This responds to your August 31 letter regarding discrepancies in the Schedule D of America's Political Action Committee's 2007 Midyear Report.


First, contrary to the appearance of some of the data, no debts have been credited or forgiven by any vendors to America's PAC. The minus figures have been created by mistakes made in reporting disbursements, probably in reporting disbursements for current charges as payments of debt.

As I said in our phone conversation today, this seems clearest in the Allied Envelope item in Debts and Obligations showing -\$4,465.50. Four of the disbursements in our 7/31/05 report which amount to that figure were current charges that were reported as debt payments.

So far, this one seems the easiest to correct. I hope I can have a few more days to figure the remaining items, but will get an amended report to you as soon as we can.
