Thank you for your letter of May 25, 2016. I have read your correspondence carefully and reviewed our filings for Fund for America's Future (C00388934).

We mistakenly designated a donation of \$5,000 to The Richard Burr Committee for the Primary Election after the Primary Election had occurred. It should have been designated for the General Election, and we regret the clerical error.

While we would like to rectify the situation by redesignating the donation to the General Election, we are now outside of the 60-day window when that process can be done via written authorization from our PAC. Therefore, we have requested a refund of the \$5,000 donation.
