Dear Mr. Vuong:

This is in response to your letter of March 3, 2010, requesting additional information on the above referenced report. Items requested are addressed below.

1. Schedule A of our report disclosed two contributions from a person, James Dolan, in 2009, exceeding the \$5000 per year limit. This error was discovered in January, 2010, and corrected with a prompt refund and full disclosure in our year-end report.
2. Schedule B of our report disclosed three \$2500 contributions in 2009 to Bennet for Colorado. The third payment of \$2500 was mistakenly checked for the Primary Election, when the intent was to check the General Election box. Upon notification of this error, a refund of \$2500 was promptly secured, as shown by the attached refund check copy from Bennet for Colorado. This refund will be disclosed on Line 16 of the report to be filed with you on April 20, 2010.


