
Dear Mr. Holley:

We are in receipt of the FEC's latest letter to the Perdue for Senate campaign. Thank you for providing us with an opportunity to respond to the two issues raised in the letter. On the first regarding the 48 hour notices, we have reviewed our files, and we have concluded that the contributions you cite are indeed outliers to an overall pattern of timely reporting. These three incidents were ultimately reported, and in the light of the issues, we have retained additional compliance staff and persons to assist with all matters related to the campaign's financial disclosures. We request that the FEC review this in light of the fact that 114 of the 48 hour contributions were successfully reported and the campaign has undertaken significant expenditures to enhance our compliance efforts.

In regards to the loans that were made in excess of \$250,000, the campaign will not use any funds raised 20 days after the election to repay those loans; and we are preparing an amended disclosure report to show that any loaned funds in excess of \$250,000 will be deemed a contribution from Mr. Perdue to the campaign.

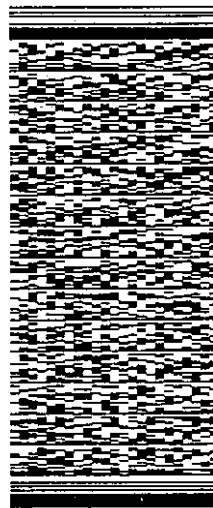

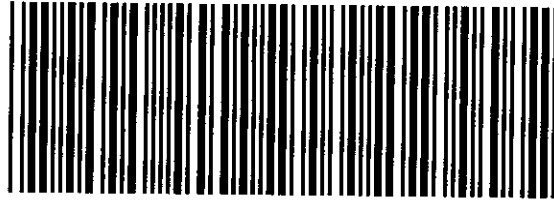

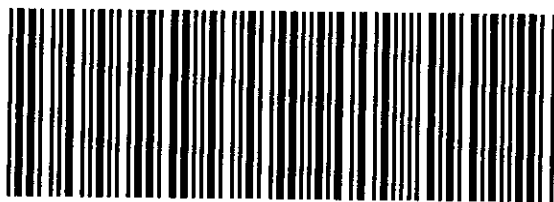
