Your letter of March 24, 1999, to W. M. Weaber, Treasurer of the Bayer Corporation Political Action Committee has been referred to me for response. You noted that Schedule B, supporting line 23 discloses contributions to candidates for the 1998 general election, however the funds were disbursed after the election date. I immediately reviewed our records and phoned your office to discuss.

Per your suggestion, enclosed you will find Amended Schedule B, supporting line 23 amending our records to indicate the actual date of the disbursement instead of the last day of the reporting cycle.

Your second question concerns Schedule B disclosing contributions to "Lauch Faircloth for Senate Committee" which appear to exceed the limits. I have reviewed our records and the contribution dated 11/14/97 should have been designated as "Primary" instead of "General".
