

Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following ⁵ items:

1. Schedule A of your report discloses apparent in-kind contributions to your committee. Please be advised that in-kind contributions are contributions of goods, services or property offered free or at less than the usual and normal charge. The value of in-kind contributions must be added to the receipts and disbursements total in order to avoid either inflating or deflating the cash on hand amount, and itemized on the appropriate Schedules A and B. 11 CFR § 104.13(a)(2) Please amend your report by itemizing the in-kind contributions on Schedule B or providing clarification regarding these apparent in-kind contributions.

2. Line 23 of the Detailed Summary Page discloses \$13,500 in contributions to federal candidates and committees. However, a Schedule B has not been provided to support Line 23. Please be advised each contribution made to a federal candidate or committee must be itemized on Schedule B regardless of the amount contributed. 11 CFR §104.3(b)(3)(v). Furthermore, Schedule B supporting Line 29 discloses activity totaling \$13,500. However, this amount has not been entered on Line 29 of the Detailed Summary Page. 
