
Dear Ryan,

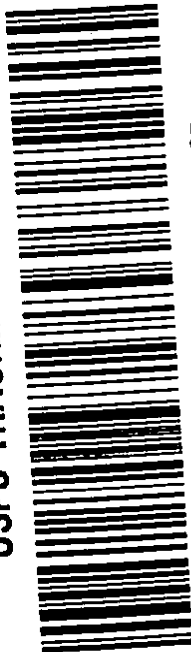

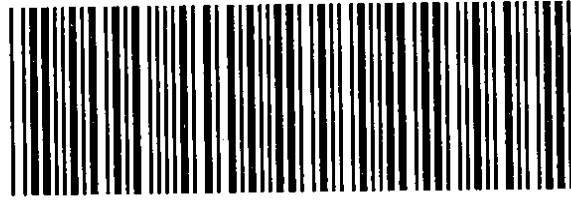

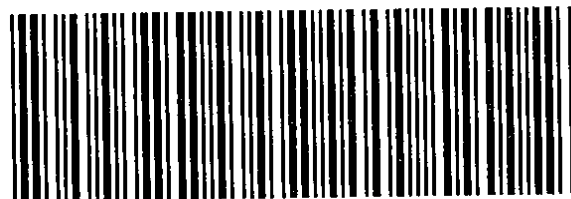
