Kevin McQueen, Campaign Finance Analyst with the Reports Analysis Division notified GARVERPAC on May 9, 2017 that the beginning cash balance of the Quarterly Report I submitted in October 2016 did not match the ending balance of the Quarterly Report I submitted in July 2016.

Upon review, I determined I made a typographical error when entering the beginning balance of the 07/01/2016 - 09/30/2016 Quarterly Report. When transferring the ending balance of \$66,421.85 from the 04/01/2016 - 06/30/2016 report to the beginning balance of the 07/01/2016 - 09/30/2016 report, I mistakenly entered \$64,421.85. Now that I've corrected my typographical error, the math works perfectly for the 07/01/2016 - 09/30/2016 Quarterly Report.
