Dear Ms. Daughtrey;

This letter is in response to your inquiry dated October 31, 2007 regarding our March Monthly Report that was filed with the Federal Election Commission on March 20, 2007.

After an exhaustive internal review, the New Hampshire Republican State Committee has discovered the following:

1. All Federal Operating Expenditures by the New Hampshire Republican State Committee during period covered by the report were made using only funds from the Committee's federal account.

While the expenditures recorded in Schedule H4 of our March report would have qualified as allocable expenses under 11 C.F.R. §106.7(c), we have learned that they should have been listed as Other Federal Operating Expenses on line 21(b) of the Detailed Summary Page and itemized, as appropriate, on Schedule B. Our March report has been amended to correct this filing error.

2. Regarding your specific inquiry into the payments itemized on Schedule H4 as "941 taxpayment - 4<sup>th</sup> Quarter", "Allocable Portion - 4<sup>th</sup> quarter 940 Tax," and "Payroll", these payments for salaries and wages were for employees who qualified for allocation under §300.33(d)(1). However, as indicated above, we have learned that all Federal Operating Expenditures were made using funds from the Committee's federal account. Our March report has been amended to correct this filing error and reflect these expenditures on Schedule B supporting Line 21(b) of the Detailed Summary Page.

3. Regarding your specific inquiry into the payments itemized on Schedule H4 as "Office Cleaning Expense", this payment was made directly to an independent contractor for cleaning services and qualifies for allocation under §106.7(c)(2). However, as indicated above, we have learned that all Federal Operating Expenditures were made using funds from the Committee's federal account. Our March report has been amended to correct this filing error.

We hope that this response provides sufficient clarity to your inquiry. Please do not hesitate to contact us with any questions or concerns.
