AMENDMENT NO. 1 TO THE BYLAWS

OF

BLUCORA, INC. PAC

(adopted October 31, 2017)

The Blucora, Inc. PAC (the "PAC") does hereby certify:

- 1. The Bylaws of the PAC adopted on February 13, 2015 stated that the initial Directors of the PAC were Nathan Garnett, Julia Hargraves, and Eric Emans.
- 2. Nathan Garnett and Julia Hargraves are no longer employed by Blucora, Inc. or its subsidiaries or affiliates and are hereby removed as Directors of the PAC.
- 3. Eric Emans, as the sole remaining Director of the PAC, does hereby desire to appoint the new Directors set forth in Section 4 below and the new officers set forth in Section 5 below and resign as a Director following said appointment.
- 4. Article IV, Section 2 of the Bylaws of the PAC is amended to read in its entirety as follows:
 - Section 2: Number; Selection; Tenure; Qualifications. The PAC Board shall consist of no fewer than 3 voting directors (the "Directors"). The number of Directors may be changed from time to time by amendment to these Bylaws, provided that no decrease in the number shall have the effect of shortening the term of any incumbent Director. Unless a Director dies, resigns or is removed, he or she shall hold office until his or her successor is appointed. Directors of the PAC Board may also serve as Officers of the PAC, and may also serve as directors and officers of the Corporation. Only United States citizens and individuals who have been lawfully admitted to the United States for permanent residence may serve as Directors. Directors may have such additional qualifications as the Board may prescribe by amendment to these Bylaws. Effective as of the date of this Amendment, the Directors of the PAC shall include Sanjay Baskaran, John Palmer and Ann J. Bruder.
- 5. Article VI, Section 6 of the Bylaws of the PAC is amended to read in its entirety as follows:

Section 6: Officers. The officers of the PAC shall be as follows:

Board Chair: Sanjay Baskaran Board Vice Chair: Ann J. Bruder

Treasurer: John Palmer

Assistant Treasurer: Jacob Hodges
