This letter is in response to your inquiry dated April 16, 2008 in which you reference the Year-End Report (12/1/07 – 12/31/07).

Schedule A – Line 15

The referenced transaction is a reimbursement from Stevens for Senate for its share of an expenditure for survey research as described. The original vendor, Moore Information, was reported on Schedule B, Line 21 of the Year End Report. In addition, as reported, the reimbursement was from the Stevens for Senate Committee. The Committee has amended Schedule A, Line 15 to clarify the transaction description.

Schedule A – Line 12 (Open Seat & Challenger Fund transfer)

The transfer from the Open Seat & Challenger fund in the amount of \$2,857.24 represents the final net proceeds from joint fundraising activity as you referenced and is described as such because all donors were previously disclosed on the amended Post-General Report 2006 (10/19/06 – 11/27/06) filed on 12/15/06. Therefore, no amendment is necessary.

Schedule A – Line 12 (McConnell Majority Committee transfers & memo transactions)

The Committee has amended Schedule A, Line 12 to add a donor memo transaction that was inadvertently omitted from the original report. With this correction, the aggregate memo transaction amount now exceeds the net transfer total on the combined transfers on the reports you referenced.


Schedule A, Line 11(c) – Receipt Type Clarifications



