
Re: Douglas Robison Campaign Contribution to "Denton County Republican Victory Fund"

Dear Mr. Buckley:

I am in receipt of your letter of June 4, 2012 regarding an alleged contribution of a total of \$2,900 to the "Denton County Republican Victory Fund." Please be advised that I thought my campaign was buying tickets to our annual dinner and not making a contribution which would require registration as a political action committee under federal law. In any event, assuming that the intricacies of federal election law have been properly applied in this case, of which I am uncertain as I am not an expert in such law, I have selected option two set forth in your letter. I have instructed that the funds contributed by my campaign are to be segregated into a separate account and not used to influence any federal election or are to be refunded. A copy of the letter I have sent to the Denton County Republican Party and/or the "Victory Fund" is enclosed for your review to show my compliance to the request made in your letter of June 4, 2012.


I hope all is well with you and that you enjoyed the State Convention. I left you a voice mail regarding the topic of this letter and given the topic must follow up with formal correspondence.

Enclosed please find a letter from Daniel Buckley of the Federal Election Commission regarding a contribution in excess of \$1,000 to the "Denton County Republican Victory Fund", and an attachment to Mr. Buckley's letter showing that I made a \$2,500 contribution and a \$400 contribution. These "contributions" were for tickets to the Lincoln Reagan Dinner and I just made out the contribution checks to the named payee per instructions from the local party volunteer.

Assuming that Mr. Buckley is correct in his interpretation of federal campaign law, which is a topic with which I am completely unfamiliar, please be advised that the \$2,900 contributed by my re-election campaign to the "Republican Victory Fund" must be transferred to an account that will not be used to influence or affect the outcome of any federal elections.
