This memo pertains to the letter sent on August 30, 2012 requesting additional information on the following items:

1.Commission Regulations require that a committee disclose the identification of all individuals who contribute in excess of \$200 in a calendar year?

The following employer and occupation entries appear on your report and are not considered acceptable: "Information requested/Information requested."

In response to this inquiry, all Sierra Club Political Committee solicitations request the occupation and the employer of the contributor. If the information is not received at the time of the request, we send the following letter within thirty days:

Thank you for your contribution to Sierra Club Political Committee, we appreciate your support!

Federal law requires political committees to report the name, mailing address, occupation and name of employer for each individual who contributes more than \$200 in a calendar year. Your accumulated year to date contribution totals\_\_\_\_\_, with the last contribution made on\_\_\_\_\_.

Please help us comply with that requirement by providing the information requested below and returning this letter in the envelope provided. If you have no employer and are retired or self-employed etc., please state so.

SCPC is a political committee. Unless otherwise notified, 100% of your contribution will be applied to your contribution limit under federal law. Contributions to SCPC are entirely voluntary.

SCPC cannot accept money from corporations (including professional corporations) or from individuals who are not United States citizens or permanent residents.
