This amendment is being filed in response to the September 6, 2016 Request for Additional Information ("RFAI") from the FEC concerning the National Restaurant Association PAC (Restaurant PAC) July Monthly report (06/01/2016-06/30/2016) received on July 19, 2016. Specifically, the RFAI notes that Schedule B supporting Line 23 discloses a contribution to a candidate for the June 7, 2016 Primary election in North Carolina after the primary election occurred. Upon receipt of the RFAI, Restaurant PAC investigated the Hudson for Congress redesignation originally disclosed on the report as dated June 15, 2016 and discovered that the actual redesignation occurred on June 1, 2016. The clerical error has been corrected on the amended report; therefore, the redesignation occurred prior to the June 7, 2016 Primary election in North Carolina. We trust that this response fully and adequately responds to your request for additional information.
