Dear Mr. Strabala:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The Summary Page discloses \$44,826.65 on Line 7, Column B, but the Detailed Summary Page shows the Line 30, Column B total to be \$55,520,50. These figures should be the same. Please amend your report accordingly.

-For your information, all contributions received that aggregate \$200 or less per individual for the calendar year should be reported on Line 11(a)(ii). Contributions received aggregating over \$200 per individual for the calendar year should be reported on Line 11(a)(i) and itemized on Schedule A.

-For future filings, please note that your committee need only file the pages on which you have itemized activity. Schedules with no activity may be omitted.

-Contributions to candidate committees and federal committees are not allocable disbursements. Please amend your report by removing references to campaign contributions from your Schedule H2.


-Please amend your report to disclose contributions to candidate committees on a separate Schedule B for Line 23.
