The Fairfax County Democratic Committee employs one full time employee, the Executive Director, whose time was less than 25 percent devoted to federal elections and candidates during this reporting period. No other entity pays compensation for their employees to work for the Committee. The Committee does not engage in any fundraising on behalf of candidates for Federal office, so all of its reported fundraising expenses are party fundraising. The Committee maintains both Federal and Non Federal accounts. The Committee is allocating administrative expenses using the 72% - 28% split this year. This amendment re-runs the report using the new version of NGP which uses a slightly different method of calculating the federal share for allocated activity to ensure consistency with other reports for 2015.
