This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 21(b) of the Detailed Summary Page of your report discloses a total of \$6,936.51 in other federal operating expenditures. The sum of the entries itemized on Schedule B, however, indicates the total to be \$7,520.51. Please amend your report to clarify the discrepancy.

-Line 23 of the Detailed Summary Page of your report discloses a total of \$22,500 in contributions to federal candidates and committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$23,330.59. Please amend your report to clarify the discrepancy.

-Please identify the name and address of the vendor for the in-kind contribution(s) disclosed on Schedule B for Line 23.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
