In an upcoming electronic filing, TXBiz Leadership Fund will be amending its Termination Report to include a \$10,000 contribution received from The Continuum Fund, Zachry Holdings, Inc. PAC and the ultimate distribution of those funds. It was the donor's intent to allocate \$5,000 of this contribution to TXBiz FedPAC (Committee ID: C00505818) and the remaining \$5,000 contribution to TXBiz PAC (a non-federal PAC registered with the Texas Ethics Commission). The \$10,000 received from The Continuum Fund, Zachry Holdings, Inc. PAC was distributed to TXBiz FedPAC and TXBiz PAC, per that donor's intent, well within the time period for redesignation and TXBiz Leadership Fund has since terminated.
