Dear Mr. Sackett:

This letter is prompted by the Commission's preliminary review of your amended Statement of Organization dated 9/20/96. The review raised questions concerning certain information contained in the Statement. An itemization follows:

-Line 5(a) indicates that your committee is a principal campaign committee. A principal campaign committee is a committee authorized by the candidate as the principal committee of his or her campaign. 11 CFR §100.5(e)(1).

If your committee is a principal campaign committee, then an amended Statement of Organization should be submitted which identifies the candidate.


A separate segregated fund is a political committee established, financed, maintained or controlled by a corporation, labor organization, membership organization, cooperative or trade association.

If your committee is a separate segregated fund, then an amended Statement of Organization should be submitted which identifies the connected organization (11 CFR §102.2(a)(1)(ii)) and the type of connected organization. Moreover, in accordance with 2 U.S.C. §432(e)(5), the name of any separate segregated fund is required to include the name of its connected organization. This includes any abbreviation within its title.

Please amend your Statement of Organization to indicate the appropriate type of committee. 11 CFR §102.2(a)(1)(i)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
