Dear Ms. Wall:

This responds to your letter of October 26, 1994 in which you raised certain questions concerning information contained in reports filed on behalf of Robins, Kaplan, Miller & Ciresi PAC. Specifically, you note in your letter that:

1. due to a gap in the coverage dates for reports filed on behalf of the PAC, a 1993 July Quarterly Report should be filed to disclose activity from (4/1/93-6/30/93); and
2. reports filed for the current election cycle do not reflect the appropriate coverage dates for quarterly filing status.

As to question 1, I am at a loss as to why the report was not filed; but I have checked our files thoroughly and can find no record of it. Accordingly, I enclose herewith for filing on behalf of the PAC a 1993 July Quarterly Report showing activity from (4/1/93-6/30/93).



As to question 2, we have reviewed our records and have determined that no 12-day Pre-Primary Report or 12-day Pre-General Election report were required to be filed as the PAC did not make any contributions during the relevant reporting periods. A contribution was made to "Sabo for Congress" on August 30, 1994. However, as this contribution was made less than 20 days before the Minnesota primary election, which was held on September 12, 1994, the contribution was properly reported in our 1994 October Quarterly Report as opposed to a Pre-Primary Report. The PAC also made a contribution to "The Tom Sawyer Committee" on October 20, 1994. As this contribution was made less than 20 days before the general election today, it will be reflected in a 30-day Post-General Election Report which the PAC will file by December 8, 1994.
