Dear Mr. Ciaraldi

It was a pleasure to talk to you on the phone last week about the letter you sent on February 23, 2000. Your letter addressed two problems you found with our year end report.

The first problem was we failed to include a schedule H2 for a Fundraiser we had on 9/18/2000. I have sense amended the report to correct the problem. However, I was unable to upload the amendment. So I will attach a copy of the schedule H2. I have contacted via e-mail Jeff Chumley in the Electronic Filing Department and have sent a copy of our fctcc.dcf file to see if he can find out what our problem with uploading is. As you may be aware the manual for FECfile is currently under development so it has been difficult when problems occur to correct the problems. As soon as Jeff gives us a fix for the upload problem we will upload the amendment.

The second problem you have indicated is the lack of administrative expenses. Our committee is run by volunteers including myself. We pay all of expenses from the Federal account and allocate money from our State account using the Ballot method for most expenses and the Funds Received method for fundraisers. Our office is opened year round, usually for 4-6 hrs a day for 3-5 days a week, and is manned by volunteers, mostly retired women. We do have a Program Coordinator who we contract to supervise the office based on activity. Payments to her have been fully disclosed and allocated form the state account.

Methods of allocation :

- 1). FUNDRAISING activities are allocated using the 'funds received method' where the federal proportion of expenses must equal the federal proportion of monies raised.
- 2). EXEMPT activities are allocated using the 'time and space method' where the federal proportion of disbursements is based on the proportion of time or space devoted to federal candidates.
- 3). Shared DIRECT CANDIDATE SUPPORT activities are allocated according to benefit expected to be derived, where the federal proportion of disbursements is based on benefit derived by federal candidates from the activity.
