Pursuant to 52 U.S.C. § 30101(4)(A) inter alia,

"[t]he term "political committee" means — any committee, club, association, or other group of persons which receives contributions aggregating in excess of \$1,000 during a calendar year or which makes expenditures aggregating in excess of \$1,000 during a calendar year [...],"

and by such definitions JUSTICE 4 KAROLINA INITIATIVE d/b/a THE KOALITION with EIN 47-3845559 is not a political committee.

Further, as of December 31^{st} , 2015, JUSTICE 4 KAROLINA INITIATIVE d/b/a THE KOALITION is no longer existing, or seeking to exist, as a political committee.

And further, there are absolutely no contributions and/or receipts and/or disbursements and/or expenditures to report with regards to the above-mentioned business entity's quest to become a fully operational independent-expenditures only political committee.

Therefore, JUSTICE 4 KAROLINA INITIATIVE d/b/a THE KOALITION seeks to be absolved from any duty to file a year-end report for any political committee activity between 07/01/2015 thru 12/31/2015. A zeroed-out was completed; however, it cannot be accessed at this moment.

At the onset, the idea to establish JUSTICE 4 KAROLINA INITIATIVE d/b/a THE KOALITION represents my legal and just effort to bring resolution to my now 40 years long post-Civil Rights Movement Sociopolitical Hostage Crisis. Around June/July 1975, I was taken into captivity by a group of Black American Clergy Couples and others after being attacked several months earlier during a violent Home Invasion and later by a brutal Bioterrorism Attack on the island of Bermuda. My physical appearance was grossly altered by the caustic Bioterrorism I was a high-ranking US Government Authority/UN Representative at the time; and, I was also returning to my legal ancestry as the Billionaire Heiress/Business Owner and Granddaughter of J.D., Sr. and Laura (Spelman) Rockefeller. a result of tragedy within that family lineage several decades earlier, I had recovered from my injuries with modified WITSEC protection within the family lineage of Joseph, Sr. and Rose (Fitzgerald) Kennedy, parents of 35th US President John F. Kennedy.

Overall, the nature of my Hostage-Taking is worthy of a Presidential-level Commission with regards to security and safety concerns to which US/State Government Authorities as well as many Corporate Executives, and their close kin and kith, are often subjected. Haven't you seen Denzel Washington's "Ricochet" and Sandra Bullock's "The Net" and Nikki DeLoach's "The Net 2.0" and Jodie Foster's "The Silence of the Lambs?" Thus, my quest to "establish justice" for myself was equally matched by my willingness to "secure the Blessings of Liberty to ourselves and our Posterity," in particular with regards to National Security issues that arise when US Government Authorities not protected by other Federal Statutes must seek assistance with legal intervention under 18 U.S.C. § § 111, 115, 1028A and 1114 inter alia.
