Dear Mr. Blackwelder:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B supporting line 21(b) of you report discloses a \$1,436 payment to your connected organization for "Bradley Campaign" (pertinent portion(s) attached). 2 U.S.C §441b prohibits a corporation or labor organization from contributing or expending funds for the purpose of influencing any federal election; however, a connected organization may pay for the solicitation and administrative costs of its separate segregated fund.

Please amend your report to clarify whether the payment to your connected organization was for expenditures which were intended to influence a federal election. In addition, please provide the specific date(s) on which the in-kind contributions were made to each federal candidate and the date(s) your connected organization was reimbursed for the services provided. Although the Commission may take further legal action concerning this matter, your prompt action will be taken into consideration.


-Please provide the total(s) for Line 21(b), Columns A and B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-Please amend Schedule B supporting Line 23 by providing the address, office sought (House, Senate, or President), including state and

congressional district, if applicable, and specific date for each contribution
made. 11 CFR §104.3(b)(3)(ii) and (v)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
