Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Senate Public Records Office by the response date noted above. Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 item(s):

1. The beginning cash balance of this report does not equal the ending balance of your 2013 July Quarterly Report. Please correct this discrepancy and amend all subsequent reports that may be affected by the correction. (52 U.S.C. § 30104(b)(1) (formerly 2 U.S.C. § 434(b)(1)) and 11 CFR § 104.3(a)(1))
2. Your amended report discloses an increase in disbursements totaling \$201,301.32 on Lines 17 and 21 of the Detailed Summary Page from those disclosed on your original report. **The Commission notes your explanation regarding the increase in activity on the amended report.** Please provide **any additional** clarifying information as to why this activity was not disclosed on your original report. (11 CFR § 104.3)
3. Your report has been amended to disclose \$200,000 on Line 21 of the Detailed Summary Page. If this amount includes any disbursement to an entity that aggregates in excess of \$200 during the election cycle, then this disbursement must be itemized on Schedule B. Please amend your report by providing a schedule B for the disbursement or provide clarifying information. (52 U.S.C. § 30104(b)(6)(A) (formerly 2 U.S.C. § 434(b)(6)(A)) and 11 CFR § 104.3(b)(4)(vi))

Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated.
