In our Post General Report we report a refund of overpaid expenditures from our federal to our nonfederal account. In the months of June and July 2006 we had event expenses which we allocated according to the "funds received" method. We estimated the percentage rate to be 85% nonfederal and 15% federal. When all contributions were received and we re-calculated the percentage rate it was actually 40% nonfederal and 60% federal, which resulted in an overpayment of \$1,834.13. We refunded this amount to our nonfederal account on 12/18/06 and are enclosing a copy of the check as well as a computation sheet.


