The referenced expenditure by the NCMA PAC was not for the purpose of enabling NCMA to influence a federal election. The expenditure was to reimburse NCMA for the cost of event room and refreshment costs (in-kind expenses) that were billed by the event hotel in error to NCMA instead of NCMA PAC. NCMA recognizes that it should have returned the bill to the hotel and requested that it be re-billed to the NCMA PAC. We have taken measures to ensure that this does not happen in future events.

NCMA PAC has amended Schedule B, enclosed, to properly reflect that the \$2,306.62 reported was for in-kind expenses related to the Salazar fundraiser event to be charged against the primary election total for Salazar for Senate.
