Dear Ms. Broomhead:

This letter is in response to your request for information relating to ACPAC's amended 12 Day
Prè-General Report and the additional receipts included on the report.

These contributions were not reported on the original report due to a data entry error. When the
contributions were entered into ACPAC's payment processing system, the person entering the
credit card information put the transactions in authorize status rather than sale status. Those
amounts subsequently were not included in the FEC report for that time period. The reporting
error was discovered and ACPAC filed an amended report on February 7, 2011 to include those
contributions and corresponding interest earned on that amount so as to accurately reflect the
contributions received from October 1-13, 2010.

In addition, one contribution in the amount of \$250 was erroneously reported on the amended
report as having come from a person who did not contribute money to ACPAC. That reporting
error was corrected and the appropriate contributor identified on the amended report that
ACPAC filed on May 11, 2011.
