As per a Request for Additional Information (copy attached), dated December 20, 2013, that was received from the Federal Election Commission, we are hereby submitting an AMENDED Form FE3 for the Quarter ending September 30, 2013.

You should find the following documents attached, as per the instructions from Ms. Robin Kelly, Senior Campaign Finance Analyst with the Reports Analysis Division:

- Form FE3, Page 1 (with checkbox "Amended" checked)
- Schedule B, Page 248 of 272 reflecting an updated description for the July 12, 2013 disbursement to Red Sea, LLC. The original description read, "third quarter consulting." The revised description reads, "Campaign strategy and consulting." Red Sea, LLC offers advertising, polling and strategic communications services.
- Schedule B, Page 263 of 272 reflecting a memo entry for a payment to Rian Bessinger on July 12, 2013 for \$32.55. A memo entry was absent on the original filing. The amended filing reflects a memo entry for \$32.55 to Office Depot for purchase of office supplies and labels.
- Schedule B, Page 264 of 272 for two reimbursements to Rian Bessinger on August 9, 2013 for \$3.79 and on August 23, 2013 for \$20.95. Neither reimbursement were for payments to vendors whose aggregate totals exceed \$200 in the current election cycle. A memo/note is shown stating such with the amended filing.
- Schedule B, Page 265 of 272 for a reimbursement to Rian Bessinger on September 20, 2013 for \$6.55. The reimbursement was for a payment to a vendor whose aggregate

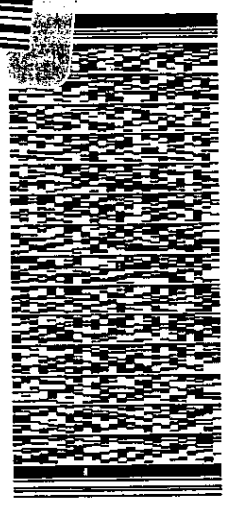

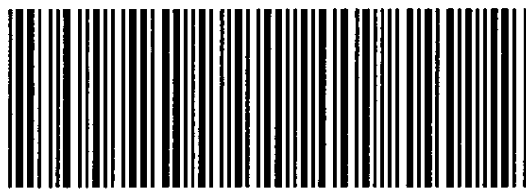
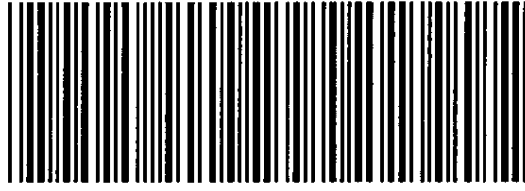
