Details of Robyn Helmer's Entries -- It was discovered that Robyn Helmer's deductions were doubled in the payroll deduction contribution system. There were 3 entries made in June 2014 to reflect the correctiong actions: 1) an \$800.00 negative receipt was reported for Ms. Helmer in order to accurately reflect her current year-to-date contributions; 2) a disbursement to Ms. Helmer of \$2,640.00 was reported related to prior year over deductions and 3) a disbursement to Ms. Helmer of \$800.00 was reported related to current year over deductions. Note: the disbursement was made with Peabody PAC check number 1297 in the total amount of \$3,440.00. --- The \$800 negative receipt entered in June was suggested by the FEC analysis, but in fact, the reimbursement of \$800.00 would have accurately reflected her year-to-date contributions. In effect, the negative receipt and the \$800.00 disbursement (refunding Ms Helmer) doubled the entry and caused her year-todate be incorrect. --- Teri Graff called Paul Stotzer (202-694-1393) of the FEC on January 20, 2015, explained the situation and asked if the June report should be amended and he said that was not necessary; an entry of a receipt of \$800.00 for Ms. Helmer would bring her year-todate amount to the correct amount of \$1,920.00 and no amendment was necessary.
