This letter is in reference to the Mailgram sent to Laboratory Corporation of America Holdings Political Participation Committee on 11/2/00 regarding a missing PAC report for the period of 7/1/00 through 09/30/00. There was some confusion on whether LabCorp needed to file a report or not. On 10/9/00, I called the Federal Elections Committee toll free number 1-800-424-9530 and talked to Gary Mullen asking some questions regarding PAC reports and which ones LabCorp should be filing. Mr. Mullen told me that LabCorp did not have to file another report until 12/7/00 if there had been no activity, such as contributions to candidates. LabCorp had made no contributions to political candidates and therefore did not file a report. When the Mailgram came stating that we had failed to send in a report, I called Mr. Mullen back and asked him why LabCorp received this letter. As the conversation went on, I realized that I had misunderstood the term "no activity". I thought that since he had stated, no contributions to candidates, the missing report did not need to be filed. I did not realize that "activity" meant contributions from employees into the fund also. I apologize for the confusion and I have attached the completed report. Please let me know if there is anything else that I need to do to rectify this situation.
