We represent Perdue for Senate, Inc. ("Campaign"), and we have received your January 15, 2015 letter regarding the Campaign's 30 Day Post-General Report (10/15-/2014 – 11/24/2014). Please find this letter responsive to your questions, and know that we will be filing an amended campaign report in the very near future. The amended report will be consistent with the representations contained in this communication, and we anticipate the amended report will be filed no later than February 28, 2015.

1. Contributions from Corporate Entities

Your letter identifies a contribution from "Campaign Solutions" on November 4, 2014, and it requests information on the corporate status of the contributor. Campaign Solutions is a vendor that collects online contributions for the Campaign. The 30 Day Post-General Report did not sufficiently break out those contributions, and a corrected disclosure will be included in the amended report.

2. Contributions Limitations

Your letter also identifies several campaign contributions that may have appeared to be in excess of the contribution limits. As an initial matter, you correctly pointed out that the Denali Leadership PAC made two \$5,000 contributions: one on August 12, 2014 and another on October 22, 2014. The second check was expressly for "2014 Debt Retirement", and it was applied to the 2014 primary-runoff election debt.

Further, as explained in our February 16 letter, after the 2014 general election, the Campaign engaged in a thorough audit of the primary, primary runoff, and general elections. That process revealed several obligations incurred with respect to the primary and primary runoff elections that were not previously known, or that were attributed to the wrong election. *See* 11 C.F.R. SEC 110.1(b)(3)(iii). The corrections will be documented on the forthcoming amended report.

As a result of the new debt calculation, the Campaign has refunded various amounts to political action committees and individuals. Other contributions from those individual contributors identified in your letter have been redesignated. The redesignations were triggered by a recalculation of net debt outstanding pursuant to a review of the Campaign's finances and additional invoices. Where applicable, the redesignated campaign contributions were from contributors who made the contribution after the primary but before the general election. *See* 11 C.F.R. § 110(b)(5)(ii)(C). The contributors did not designate their contribution for any particular election. *Id.*, *see also* Advisory Opinion 2009-15 (White).¹ And, the campaign did not anticipate the necessity for redesignation until after (1) the general election and (2) the recalculation of net debt outstanding based on the audit and additional invoices. *See* Advisory Opinion 1992-15 (Russo). Finally, each of the named contributors each received notice from the Campaign within 60 days of receipt of the contribution. 11 C.F.R. § 110(b)(5)(ii)(B) and 110(b)(5)(ii)(C). These redesignations will be reflected in the forthcoming amended report.

Attached as "Exhibit 1" are copies of refunded checks, and attached as "Exhibit 2" are letters informing those contributors whose excess contributions were redesignated by the Campaign.

3. Contributions From Persons with Foreign Addresses

Your letter questions a contribution from Janet Cotton, who maintains an address in Mexico. The Campaign has no knowledge – actual or implied – that Ms. Cotton is a foreign national, and her passport papers have been requested. Should a refund be issued, the Campaign will amend its report further to demonstrate this.

¹ The Campaign's disclosure also alerted contributors of how the Campaign would prioritize and allocate any contributions that exceeded the limit for a particular election.

4. 48 Hour Notices

The 48 Hour Notices cited in your letter were filed. Copies of the report and fax confirmations are attached as "Exhibit 3."

5. 48 Hour Notices on Schedule A

The letter cites to some of the 48 hour notices not appearing on Schedule A. This oversight has been corrected on the forthcoming amended report.

6. Disclosure of Loan Proceeds


The disclosures regarding Senator Perdue's loans to the Campaign will be corrected on the forthcoming amended report.

7. Explanation of Itemized Disbursements

In points seven through nine, the letter raises issues with the itemized disbursements. Specifically, the letter addresses phrases "Blank," "Event Expense," and "See Below, vendor disbursements, and travel-related disbursements. These descriptions have already been corrected, and they will be properly disclosed in the forthcoming amended report.
