
Please find attached amendment of Russ for Wisconsin's 2015 October Quarterly Report. While performing an end of campaign audit several errors were discovered and are corrected in the attached report.

Corrected errors include:

- Unitemized contributions totaling \$167.50 were reported twice due to a data processing error.
- An unitemized expense of \$5 for parking was reported twice, the duplicate has been deleted.
- An expense to Actblue was originally reported as \$2.50, the actual expense was \$1,790.78. This administrative error has been corrected.
- An expense to Actblue in the amount of \$10.60 was omitted from the original report and is corrected in attached amendment.

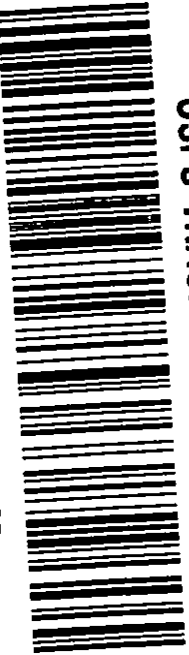

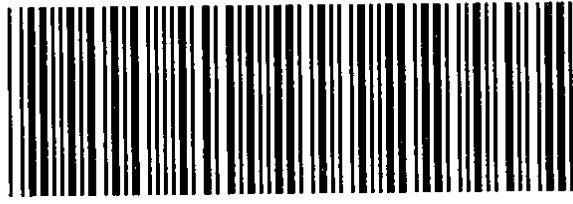

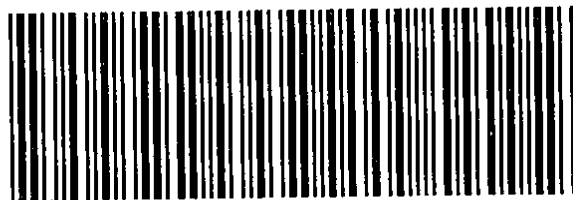
