In a letter sent to your committee on November 12, 2015, you were informed "any receipt or disbursement of funds by the committee for the purpose of influencing a federal election or supporting a federal candidate will void the administrative termination. In such an event, the committee will be required to begin filing reports with the Federal Election Commission. The first such report will include any activity since the date of the last report filed by the committee."

A review of the receipts reported by the McCarthy Victory Fund (C00541011) indicates that your organization may have made a contribution to a political committee during the 2015 calendar year. This activity may have reactivated your reporting requirements of the Act. A copy of the receipt schedule(s) which list your organization's contribution(s) is enclosed for your review.

In order to be in compliance with the Act, your organization must either:

- 1) submit an amended Statement of Organization, file disclosure reports on FEC FORM 3X disclosing any activity since your 2014 July Monthly Report (06/01/2014 - 06/30/2014) (Copies of FEC FORMs 1 and 3X can be downloaded from the FEC website at <http://www.fec.gov>, or requested through the FEC Fax line at (202) 501-3413; or
- 2) receive a full contribution refund or direct the recipient committee(s) to transfer the funds to an account not used to influence federal elections.

The second alternative noted above should be followed if your organization does not wish to be reactivated and file disclosure reports, or if the contributions or expenditures by your organization were from an account containing corporate or union funds.
