Dear Michael-Ann Henry:

In response to the Request for Additional Information (RFAI) sent on September 20, 2020 regarding the 2020 July Monthly Report (06/01/2020-06/30/2020) we have provided the requested information below.

1. Schedule A supporting Line 17 of the Detailed Summary Page discloses a receipt for "Misdeposited Funds" for \$2,900.

Detailed Explanation: COVID has had an impact on our routine operations and procedures which resulted in the misdeposit into the BOMAPAC of a check intended for a non-PAC account. However, as soon as the error was detected these funds were transferred out of the PAC account and into the correct one. BOMAPAC makes every effort to ensure that deposits are in compliance with all FEC regulations and we have now put new measures in place to prevent misdeposits from occurring again. Our new procedures include requiring approval of two separate individuals before a check may be deposited into BOMAPAC's account. Please note that the misdeposited funds were refunded to BOMA International on 8/11/20. This was disclosed on our September Monthly filing.

2. Schedule B supporting Line 28(a) discloses negative entries for refunds to individuals.

Detailed Explanation: As is noted on the report, the negative entry is a disclosure of a voided refund incorrectly issued to an individual that had already been reimbursed, resulting in a double payment. The original refund was issued on 2/26/20 and was reported on the March 20 Monthly report. An additional refund was issued via credit card and was disclosed thru a payment made to Square, less the processing fee, on 2/27/20 in the amount of \$120.47. The March monthly report has been amended to clarify this entry. All subsequent reports have also been amended to ensure proper disclosure in Column B.
