Please find attached the April Quarterly, 1994 report for the Clean Water Action/Vote Environment PAC FEC ID# C0025192.

I recently discussed with you that we were still receiving correspondence from the FEC related to a PAC we closed in 1993. This was our Vote Environment/NJEF PAC FEC ID# C00266049. A termination report was filed with our July 31, 1993 Mid Year Report. You shared with me that you were waiting on clarification from me as to where the balance of the account (\$2,074.03) was disbursed. We turned over these remaining funds to our connected organization's treasury. I hope this is the information you needed to assure this account is terminated. Let me know if you require further information.


